We hold the health, safety, and welfare of our employees, clients, and communities we serve at the forefront of our operations. We are committed to fostering a culture of safety, wellbeing, and continual improvement through our commitments and practices.

### Our commitments

- **Safe and Healthy Working Conditions:** We pledge to provide a safe place of work, safe systems of work, safe equipment, materials and substances, competent personnel and adequate resources to support our efforts.
- **Employee Empowerment and Competence:** We value our workforce and commit to:
  - Encouraging open consultation on matters affecting health, safety, and welfare.

  - Equipping our team with the necessary resources and tools to uphold high standards.
- **Proactive Risk Management:** Our workforce are expected to actively participate in:

  - Implementing risk assessments and adhering to control measures, always prioritising hazard elimination, then risk reduction, using engineering controls, using administrative controls, and using PPE only as a last resort.
  - Ensuring work equipment is fit for purpose and properly maintained.
  - Maintaining high housekeeping standards
- **Shared Responsibility:** We consider safe behaviour to be a fundamental condition of employment. Everyone is responsible for:
  - Undertaking work, using equipment and materials in accordance with guidance.
  - Cooperating with others both inside and outside the organisation.
  - Stopping work if it poses an unacceptable risk to safety or health.
  - Applying high housekeeping standards.
  - Not interfering with, or misusing, anything provided for the purpose of health and safety.

- **Legal compliance and Continual Improvement:** We view legal compliance as the minimum acceptable standard, instead we aim to exceed legal requirements through a process of continual improvement.

### Implementation and Monitoring

- **Leadership and Governance:** The Managing Director, supported by the management team, will oversee the policy's implementation, ensuring everyone contributes to creating a safe and healthy workplace as part of our operations.
- **Resources and Facilities:** Adequate resources and welfare facilities will be provided to all employees, ensuring everyone can perform their duties safely and healthily.
- **Continuous Learning and Adaptation:** This policy will be reviewed regularly to adapt to new insights, feedback, and evolving standards, ensuring our practices remain at the forefront of health, safety, and welfare management.
