



## Modern Slavery Policy Statement

# “Fighting modern slavery together”

We are committed to ethical business practices and the protection of human rights. This Modern Slavery Policy reflects our resolve to identify, prevent, and eliminate any form of modern slavery within our business operations and supply chain.

Modern slavery encompasses forced labour, human trafficking, servitude, and any type of coerced work that deprives individuals of their freedom. Our policy aligns with the UK Modern Slavery Act 2015 and underscores our dedication to conducting business responsibly and with integrity.

### Policy Objectives

- **Zero Tolerance for Modern Slavery:** To uphold a zero-tolerance stance towards modern slavery within our operations and supply chains.
- **Compliance and Due Diligence:** To ensure compliance with the UK Modern Slavery Act 2015 and conduct thorough due diligence processes to prevent modern slavery.

- **Supplier Standards:** All suppliers and contractors must comply with our Modern Slavery Policy. Contracts will explicitly prohibit modern slavery, and we will terminate agreements with any party found to be involved in such practices.

- **Employee Training:** Training programs will be provided to ensure that our employees are knowledgeable about modern slavery, recognise its signs, and understand how to report suspected cases.
- **Reporting Mechanisms:** Employees and external stakeholders can report concerns about modern slavery without fear of retaliation.

### Implementation

- **Accountability and Governance:** Accountability for implementing this policy and ensuring compliance lies with our senior management team.
